

FUZE: Terms and Conditions**A) INTRODUCTION**

FUZE, (the “Programme”) is a reality competition that offers a platform to showcase talents across a unique range of content pillars (music, dance, fashion, and technology or innovation) and honour exceptional performances or ideas.

The Programme is managed and produced by Livespot360 (“Producer”) and sponsored by Stanbic IBTC (“Sponsor”).

As an individual entering the competition (“Contestant”), submitting an online application, (“Application”) and audition video (“Audition Video”) (collectively hereafter “Digital Audition”) for consideration by the Producer, you acknowledge that you have read, understand, and voluntarily agree to abide by these Application and Digital Audition Terms and Conditions (the “Terms and Conditions”) in their entirety.

These terms and conditions set out the contractual framework for participation at the different levels of the show from digital audition stage to the grand finale.

The effective date of these Terms and Conditions (the “Effective Date”) shall be 01 August 2025.

B) ELIGIBILITY REQUIREMENTS

Contestants may only participate in the competition if:

1. You prove that you are either a citizen of Nigeria or a legal resident by uploading proof of a National identity card such as Driver’s license, permanent Voter’s card, National identification number or data page of International passport.
2. You are between the ages of 18 and 35 years as at 01 July, 2025.
3. You are willing to appear for a physical Bootcamp at your own expense in September/October, 2025. (This is only applicable to participants moving to the next round).

4. And if you scale through to the next phase, you are willing to appear for a physical audition in November/December 2025, in Lagos Nigeria, within one week's notice.
5. You must be able to demonstrate that you do not have any binding agreements with any financial institution.
6. You agree that only one (1) Digital Audition User profile may be created in connection with any e-mail address and multiple user accounts for the same person will not be considered.
7. Neither you nor any of your immediate family members (spouse, ex-spouse, parents, siblings, children, stepchildren) or members of your household (whether or not related to you) are current employees, directors, or representatives of the Producer (Livespot360).
8. You agree that if you advance to the final stage of the Programme, you will commit to attending and performing at a minimum of five (5) appearances or performances at Stanbic IBTC events during the period from December 2025 through December 2026 without any additional consideration. However, Stanbic IBTC may offer an honorarium to cover logistics for each appearance.
9. You will be provided with a minimum of 2 (two) weeks' notice prior to each scheduled appearance.

C) AUDITION VIDEO

As part of your consideration, please ensure that your audition video meets the requirements below:

1. Must be submitted before 11:59PM (WAT) on Saturday, 01, August, 2025.
2. Must be 60 seconds or less and shot in a landscape format.
3. Must be uploaded first on your social media page before you upload it on the App, as you will be required to include a link to your social media upload of the video.
4. Content must be either Music, Dance, Fashion, Technology or Innovation, and must be original and solely owned by you. It must not infringe upon or violate the rights of any other persons or entity.
5. Your submission must NOT contain any post-production voice effects or enhancements or use of image filters and distortions or AI.

6. Audition video must NOT contain obscene or discriminatory material and must not contain any visible branding either in the outfits or background.
7. Audition video does not and will not violate any applicable laws.

D) SUBMISSION GUIDELINES

Contestant agrees to abide by the following:

- 1) Create an audition/entry video according to the AUDITION VIDEO GUIDELINES.
- 2) Upload on your social media platform.
- 3) Go on the audition/entry platform (the App), fill in all fields on the application form and upload your video.
- 4) All questions on the application form must be truthfully answered. Failure to do so may result in disqualification from the competition.
- 5) Additional submission guidelines with respect to each entry category is available on the show's social media platforms.
- 6) The digital audition/entry process is free of charge.
- 7) All categories are limited to 1 individual (no groups).
- 8) Your submission will not be valid until you accept the terms and conditions stated in this document.

E) INSTRUCTIONS FOR CATEGORY SUBMISSIONS

Fashion

Upload a video (maximum of 60 seconds) showing 3 sketches or illustrations of outfits created by you alongside the final outfits.

To be clear, you are required to show 3 sketches (illustrations or designs), and the final products (the finished/completed outfits). Record yourself showing us the sketches and outfits, in a one-minute video.

Music

Upload a 60 second audition video of yourself performing a song. You may use a visible musical instrument if you want. Song must not be produced in a studio. Backing tracks are not allowed.

Dance

Upload a 60 second video showing a dance routine of your choice, using any music of your choice.

Tech and innovation

Upload yourself giving a 60 second elevator pitch explaining your Tech business and / or product. You must have a minimum viable product (MVP) & Initial Market Traction.

F) PARTICIPATION

The following are some of the guidelines to acknowledge and agree to:

- 1) Due to the format of the show, the Producer may choose to feature your digital audition in an episode of the show or request that you appear at a physical location in Lagos Nigeria to participate in a series of camera recordings, or request that you re-do and send in an improved audition video if you have scaled through to the second round. You agree to fill out, sign and return participant agreement or talent release form within the stipulated time by the Producer.
- 2) In submitting your video, Producer reserves the right to determine, in its sole discretion, if you are eligible to participate in the competition. Producer may, at its sole and absolute discretion, select any eligible person to advance to any round of the auditions and/or the competition.

- 3) You also agree to submit to medical examinations including but not limited temperature checks, COVID tests etc. at a location which the Producer may determine and by medical professionals engaged by the Producer to ensure that you meet physical and psychological requirements required for participation.
- 4) The foregoing eligibility requirements may be amended, revised or changed at any time and in Producer's sole discretion. Producer reserves the right in its sole discretion to allow anyone to participate in the competition regardless of how, when, and or whether they participated in the audition process.
- 5) Your family and or guests should be prepared to sign releases concerning the possible taping and or recording of their name, likeness, voice, conversation, etc.
- 6) You hereby agree that Producer and the Sponsors shall have no liability whatsoever for and shall be held harmless by you against any liability for any injuries, losses or damages of any kind to person(s) (including death) or property resulting in whole or in part, directly or indirectly, as a result of participating in this digital audition or reality competition.
- 7) Unless expressly approved by the Producer, you shall not make public your participation beyond the Digital Audition phase. Information regarding physical auditions, rehearsals, production meetings and pitch sessions shall not be made public knowledge.
- 8) Should you be selected to move over to the next phase and you arrive at the Bootcamp location, you agree that you may taped and photographed and recordings of your voice and conversations, including quotes, paraphrases and sounds (collectively, the "Recordings") will be used in and in connection with the Program, and in advertising, merchandising, promotion and publicity for the Program, as well as in connection with any other production and the advertising, merchandising, promotion and publicity therefore, and for any entity that exhibits in any manner the Program or any other production, in any and all media now known or hereafter devised, throughout the universe in perpetuity. You agree that Livespot360 Limited, shall be the exclusive owner of all copyright and other rights in and to the Program and the Submission Materials and will be able to use them forever and throughout the world, and to assign

them, and to license others to use them, in any manner and in any and all media now known or hereafter discovered or developed.

Producer also reserves the right to change the programme rules and procedures at any time.

G) RIGHTS AND INTELLECTUAL PROPERTY

You acknowledge that you own the rights to your Audition Video(s). By tagging the sponsors and submitting on our platform, you hereby grant to the Producer, in perpetuity the non-exclusive, royalty-free, sublicensable license to use, reproduce and distribute your Audition Video(s) as it deems fit and in whatsoever format, now known or to be invented in the future.

For the avoidance of doubt, this includes but is not limited to the absolute right to edit and or alter any Audition Video(s); distribute and synchronise all or any portion of your Audition Video(s) in timed relation to any other visual elements; to webcast, podcast, re-publish, re-telecast, re-platform, port, syndicate, route, and link to and from all or any portion of your Audition Video(s); to encrypt, encode and decode, and compress and decompress all or any portion of your Audition Video(s); to edit, mix, combine, merge, distort, superimpose, create or add special effects, illusions and or other material to or of all or any portion of your Audition Video(s); to create composite, stunt, comic or unusual photographs, Video(s), animations, motion pictures and or voice reproductions from all or a portion of your Audition Video(s); and to excerpt and or extract portions of your Audition Video(s).

H) LIABILITY

By participating in this digital audition and reality competition, you acknowledge and agree that the decision of the Producer shall be final with regard to the selection process, use of video and audio submitted or recorded by the Producer, and the determination of the award of prizes.

The Producer may at any time cancel, terminate, modify, or suspend this Digital Audition.



The Producer and the Sponsors are not responsible for any alleged damage or loss of data that results from your use of the submission platform, or any claims brought against you by a third party.

I) CHANGES

Producer reserves the right in its sole discretion to modify or change the Audition Video(s) Submission Requirements hereunder from time to time and such modifications will be effective upon posting to the Online Audition Website.

Producer also reserves the right to change these Terms and Conditions at any time, with or without notice.
