

Terms and Conditions for the Stanbic IBTC University Scholarship

1. Eligibility Criteria

This Scholarship is only available to Applicants ("Applicants", "They" or "You") who:

- a. reside in Nigeria and participated in the 2023/2024 University Tertiary Matriculation Examinations (**UTME**) conducted by the Joint Admission and Matriculation Board (JAMB).
- b. have a score of 250 and above in University Tertiary Matriculation Examinations (UTME)
- c. have gained admission and have been properly enrolled in an accredited Nigerian Federal or State University ("University") for a full-time undergraduate programme with relevant evidence.
- d. shall maintain an enrolled status at the University for the duration of your admitted degree programme.

The Stanbic IBTC University Scholarship shall not apply to employees of Stanbic IBTC and or their immediate family members, where there are entries by employees of Stanbic IBTC or their immediate family members, it will not be rewarded.

2. Agreement to official rules:

Applications for the Scholarship is open to applicants from **29 May 2024** to **30 June 2024**, no application shall be accepted after the application expiration date.

By applying, you indicate your full and unconditional agreement to, and acceptance of, the terms and conditions (as may be amended, supplemented or novated), which are final and binding on all Applicants. Winning or receiving a scholarship is contingent upon meeting **all** eligibility criterias and complying with all terms and conditions. Any misrepresentation or fraudulent information provided by an Applicant will result in immediate disqualification from the selection process.

This scholarship is not (at all) sponsored by, run by or associated with, Facebook, X, LinkedIn or Instagram.

3. How to enter:

Applicants may submit their applications by following these simple steps:

4. Scholarship Award:

- a. The Scholarship will only be awarded to 200 Applicants across the Thirty-Six (36) States of the federation and Federal Capital Territory (FCT) with a minimum of 5 Applicants per State and a maximum of 5 applicants per university.
- Scholarships will only be awarded to applicants that follow the instructions and meet all the eligibility criteria.
- c. All documents submitted by applicants will go through Stanbic IBTC verification process and also with a third-party verification agency.
- d. The Scholarship may be renewable, at the discretion of Stanbic IBTC and may be applied to subsequent academic years based on satisfactory academic progress.

5. Data Protection
